Recognizing her education at Clemson was a catalyst for her successful career, Emily established the Emily Peek Wallace '72 Scholarship Endowment for S.T.E.M., which provides scholarships for students who require financial assistance in STEM fields. When Emily Peek arrived at Clemson as a math major in 1968, she was one of the few Clemson women entering any STEM field at the time. Recipients of her endowment are encouraged to participate in the Women in Science and Engineering (W.I.S.E.) program to continue to counteract the lack of women in her field. In 1981, Emily and her husband, Jack, joined SAS Institute and were among the first 100 employees of the Cary, North Carolina company, where Emily now serves as the Senior Director of the Knowledge Management Center. Emily's philanthropic spirit was instrumental in a multi-million-dollar donation of software and services to Clemson University by SAS – a global company with 15,000 employees. 
