Legacy Month commenced with the Legacy Society Dinner to coincide with the anniversary of the signing of Thomas' Last Will & Testament on November 6, 1886, and members of the Clemson Legacy Society were also invited to add their signatures to the Clemson Legacy Registry, symbolizing the power of their personal philanthropy.



During Legacy Day, students enjoyed tours of the Fort Hill Mansion and a fun scavenger hunt to learn about the history of Fort Hill, the Calhoun family and the Clemson family. Copies of Anna and Thomas' wills were on display, and our students were invited to "leave their mark" by signing a special Clemson print. Legacy Day is a tremendous opportunity for our students to learn the history of our great University, to see the impact of philanthropy and to learn how they can honor our traditions today, tomorrow and forever.

A very special ceremony was conducted under the Second Century Oak at Fort Hill, wherein Homer '52 and Peggy Wyrosdick McConnell, of Kingston, Tennessee were inducted into the Fort Hill Legacy Society. The Homer E. McConnell, Jr. and Peggy W. McConnell Endowed Scholarship supports South Carolina students who demonstrate leadership, character and an ability to succeed. This society is a prestigious group of visionary philanthropists whose generosity leads to a gift of \$1 million or more to the University through their estate plan. 
